What we do

How does CORNERSTONE CAPITAL BANK, SSB protect my personal information?	To protect your personal information from unauthorized access and use, we use security measures that comply with federal law. These measures include computer safeguards and secured files and buildings.
How does CORNERSTONE CAPITAL BANK, SSB collect my personal information?	We collect your personal information, for example, when you <ul style="list-style-type: none">• open an account or make deposits or withdrawals from your account• pay your bills, apply for a loan, or give us your income information or phone number• provide employment information or give us your employment history• use your debit card or other credit products• apply for insurance or pay insurance premiums We also collect your personal information from others, such as credit bureaus, affiliates, or other companies.
Why can't I limit all sharing?	Federal law gives you the right to limit only <ul style="list-style-type: none">• sharing for affiliates' everyday business purposes - information about your credit worthiness• affiliates from using your information to market to you• sharing for nonaffiliates to market to you State laws and individual companies may give you additional rights to limit sharing.
