

## FORM CRS- A SUMMARY OF YOUR ADVISORY RELATIONSHIP WITH ALLIED INVESTMENT ADVISORS, LLC. February 15, 2024

#### ITEM 1 - INTRODUCTION

Allied Investment Advisors, LLC, is registered with the Securities and Exchange Commission (SEC) as an Investment Adviser. Brokerage and investment advisory services and fees differ, and it is essential for you to understand these differences. Free and simple tools are available to research firms and our Financial Professionals at <u>Investor.gov/CRS</u>. These websites also provide educational materials about broker-dealers, investment advisers, and investing.

#### ITEM 2 - RELATIONSHIPS AND SERVICES

#### WHAT INVESTMENT SERVICES AND ADVICE CAN YOU PROVIDE ME?

Allied Investment Advisors, LLC, offers investment advisory services to retail investors on a discretionary and non-discretionary basis including wealth management services, financial planning and pension consulting services, and other consulting services. Our Firm continuously monitors your investment advisory accounts, and specific investments within your accounts, on an ongoing basis to align with your investment goals. This service is included as part of the Firm's standard advisory services.

- **Discretionary:** You have granted written investment authority to your Financial Professional to execute purchase and sell orders in your advisory accounts without consulting with you first. You may limit our discretion, such as by imposing reasonable restrictions on investing in certain securities or groups of securities.
- **Non-Discretionary:** You have not granted written trading authority to your Financial Professional, and he or she will speak with you before executing trades in your account, and as the retail client, you make the ultimate decision regarding the purchase or sale of your investments.

We require a minimum portfolio value of \$250,000 and a minimum annual fee of \$3,000 in order to provide advisory services to you. This minimum portfolio value requirement is negotiable and may be waived at the firm's discretion. In addition, we offer financial planning and consulting services for our clients. Financial Planning services are included with our investment management services. Consulting services are a separate service in which the client enters into a separate consulting agreement.

### ITEM 3 - FEES, COSTS, CONFLICTS, AND STANDARD OF CONDUCT

#### WHAT FEES WILL I PAY?

Our Firm receives a fee as compensation for providing investment advisory services on your account. The investment management fee includes investment management supervision, trade entry, and other account maintenance and/or service activities. Our Firm's fees are billed as follows: Our investment management fees are based on a percentage of the total account value. Our maximum annual investment advisory fee is 1.75%, billed in advance, on a quarterly basis. The more assets in your advisory account, the more you will pay in fees, and therefore, the Firm has an incentive to encourage you to increase the asset value in your account. The custodian may charge transaction costs, custodial fees, redemption fees, retirement plan and administrative fees, or commissions. Fees for Financial Planning services are included in the investment management fees as described above. Fees for consulting services are negotiable and based on an hourly fee ranging from \$75-\$200/ hour. You will pay fees and costs whether you make or lose money on your investments. Fees and costs will reduce any amount of money you make on your investments over time. Please make sure you understand what fees and costs you are paying.

## WHAT ARE YOUR LEGAL OBLIGATIONS TO ME WHEN ACTING AS MY INVESTMENT ADVISER? HOW ELSE DOES YOUR FIRM MAKE MONEY AND WHAT CONFLICTS OF INTEREST DO YOU HAVE?

When we act as your investment adviser, we have to act in your best interest and not put our interest ahead of yours. At the same time, the way we make money creates some conflicts with your interests. You should understand and ask us about these conflicts because they can affect the investment advice we provide you. Here are some examples to help you understand what this means. 1) Asset-based fees present a conflict because our Firm is incentivized by encouraging you to invest additional funds in your advisory accounts. Asset-based fee compensation also poses a conflict when: a) Advising you to rollover a 401(k) balance, when equivalent and less costly options are available if funds are left with the employer's fund manager. b) Advising you not to pay off a mortgage (thus diminishing assets), even when the mortgage carries a high interest rate. c) Advising against making a large charitable contribution to get a tax deduction (but decrease assets under management). d) Advising you to take a margin position in your managed account and charging fees on the margin balance. 2) Our Firm utilizes solicitors and pays compensation to independent third parties for the referral of clients to our Firm. 3) Our firm allows our Financial Professionals to invest in the same securities as you; therefore, our Financial Professionals may have an incentive to favor their personal accounts over your advisory account. 4) Lastly, some of the products, services and other benefits provided by your custodians are used in servicing all of our Firm's advisory accounts and therefore may not directly benefit your advisory account. If you have questions about whether any of these situations could apply to your investments, ask your Financial Professional.

Our Firm's Financial Professionals are compensated by the investment service fees as described above in Item 3- Fee section. Our Financial Professionals are compensated based on the amount of assets they service, the amount of time spent, the complexity required to meet the client's needs, and revenue received from our assets under management. While some of our Firm's Financial Professionals are engaged in outside business activities, we are required to disclose material outside business activities and any conflicts they may pose to you. Our Firm supervises the business activities of our Financial Professionals through our compliance program. All Financial Professionals are required to follow a Code of Conduct to mitigate any conflicts to you.
